As for the future, the next RC19 annual meeting will take place in Mannheim, Germany, from August 28-30, 2019. Hosted by the University of Mannheim, its theme is 'Global Crises and Social Policy: Coping with Conflict, Migration and Climate Change'. The co-organizers are Bernhard Ebbinghaus, Alexandra Kaasch, Hildegard Theobald, and Claus Wendt.

In 2020, RC19 scholars will meet on two occasions. First, in July 2020, RC19 will organize sessions at the Fourth ISA Forum of Sociology at the Pontifical Catholic University of Rio Grande do Sul in Porto Alegre, Brazil. Second, the regular annual meeting of RC19 will take place in Taipei, Taiwan. It will be co-organised by Shih-Jiunn SHI, Jen-Der Peter LUE, Yeun-wen KU, and Chung-yang YEH, and will take place in spring 2020 (the exact dates will be announced later). In 2021, the annual meeting of RC19 will take place at the University of Fribourg in Switzerland. The co-organizers are Monica Budowski and Daniel Künzler. Finally, in 2022, RC19 will organize sessions at the 2022 XX ISA World Congress of Sociology in Melbourne, Australia. As usual, RC19 will not organize an annual meeting during the year of the ISA Congress.

As an organization, RC19 thrives only when members provide feedback about how to improve our activities and our work as an organization. Like in the past, the RC19 board always welcomes your advice about how to make our organization better and more successful, in the years to come. No organization can survive and thrive without committed board members and members at large, and RC19 has plenty of them.

Thank you again for supporting RC19. I hope to see many of you this summer in Mannheim.

## **Call for Papers and Poster Presentations**

This international conference sets out to analyze the characteristics, trajectory and impact of collaborative collective actions in a context of erosion of the welfare state. It also seeks to present and discuss the most recent innovations, trends, and concerns, as well as practical challenges encountered and solutions adopted in the fields of collaborative collective actions. The conference will address the following questions:

- How, when and where does collaborative collective action occur?
- Which are the characteristics of contemporary collaborative collective action?
- What are the practical, symbolic, and legal effects of collaborative collective actions for the forging and recovery of social bonds?
- What forms of interaction emerge from these types of actions?

We invite theoretical and empirical proposals that explore collaborative collective actions in different areas: work, production, consumption, culture, art, science, knowledge and education, solidarity with precarious groups, civic participation and politics. Topics of interest include, but are not limited to:

- **Food and agricultural production**: food sovereignty, agroecology, zero kilometer movement, food and sustainable soil experiences, urban agriculture and community gardes;
- Arts: art and the commons, collaborative art and new forms of creative commons, distributed design;
- Science: collaborative forms of scientific production, citizen science;
- **Care and co-housing**: solidarity networks for personal care, health care, age care, childcare, personal quantification movement, co-housing;
- Culture: collaborative culture, open culture movement;
- Economy, work and consumption: collaborative economy, circular economy, new forms of collaborative work and co-working, collaborative consumption, time banks, platforms for sharing resources and experiences;
- **Technology**: Maker and DIY movement, open source technology initiatives, network manufacturing, medialab experiencies, hacktivism;
- **Politics**: collaborative forms of political and institutional governance, networks of cities, institutions and citizenship, participatory democracy, participatory budgeting, open government, collective intelligence for democracy.

We encourage the submission of papers drawing on theoretical and methodological approaches from diverse fields of study, such as the social sciences, humanities, architecture, urban planning and design. We also invite contributions from actors working with citizen participation in the sciences, arts, media and/or politics (e.g. in cultural institutions, cultural policy, social media platforms, cooperatives, and NGOs).

#### 10-12 June 2019 – Sigtuna, Sweden

The Foundation for International Studies on Social Security (FISS) is pleased to invite paper proposals for its 26<sup>th</sup> Annual Research Conference to be held on 10-12 June 2019 at the Sigtunahöjden conference centre in Sigtuna, Sweden (close to Stockholm's Arlanda Airport).

The theme of this year's conference will provide an opportunity to reflect on social security-related research issues, findings and implications in order to better accommodate and respond to change.

The world economy remains uncertain and social security systems in all countries face many challenges, including: growing inequality; persistent poverty; employment precarity; new migration flows, and severe resource constraints. The future of social security depends on its ability to respond to current challenges, but change must occur in ways that promote more sustainable societies. Will those changes be enough? Will they be inclusive for all citizens? Which are the unforeseen consequences of changes introduced today on current and future societies? Are all countries moving in the same direction, and what can we learn from the successes and failings of others? What is the appropriate between balance traditional and radical approaches?

As before, the conference will provide a robust but relaxed forum for researchers and policy makers to discuss these and other issues related to the design, financing, delivery, impact, opportunities and future of social security provisions - broadly defined to include health care systems.

Reflecting its successful implementation in 2017, a special Forum Session will be devoted to an informal open discussion about the research experiences and insights of leading practitioners in the field. The theme of the 2019 Form will be: "My Brilliant Career: Reflecting on Achievements, Regrets and Mistakes (and How Best to Distinguish between Them)"

The main program will include papers contributed by participants and FISS invites submissions containing the title of the paper, the name(s) and affiliation(s) of author(s) and an Abstract of between 200 and 300 words by <u>31</u> <u>March 2019</u>. Authors will be informed whether or not their paper has been accepted by 19 April 2019.

The FISS Best Paper Prize of 300 Euros will be awarded by a selection committee from the FISS Board of Governors and the winning paper will be published in *The Journal of Poverty and Social Justice*. The author(s) will also receive two years free subscription to the journal.

The research focus is on the innovative application and further development of complex procedures and new approaches in quantitative empirical social research in sociology. Previous academic activities with an international orientation are expected. The University of Vienna is looking for an academic, who is highly qualified in research and teaching. The teaching portfolio includes courses in the areas of quantitative empirical methods and fundamentals of statistics for social scientists.

Successful candidates should have the following qualifications:
