Preface

Our Research Training Group has just celebrated its first anniversary since the first cohort of ten doctoral researchers and one post-doctoral researcher took up their positions. The research group deals with the genesis of world politics as a specific type of politics. With a research-oriented, interdisciplinary, and international profile, the major objective of the RTG is to investigate from different angles the pathways that have led to the establishment of world politics as a specific form of politics.

In this framework the doctoral students pursue, in cooperation with eleven principal investigators from political science/international relations, sociology, history, and law, their research projects in topics related to the field of world politics. Most of our researchers have drafted, and over the summer semester discussed the chapters of their dissertations and other scientific papers, both at the group's own research class, as well as at a range of international academic conferences (see list below).

Our group has also continued to benefit from a range of distinguished guests who have spent some time with us not only in order to present their own relevant research but also in order to share their thoughts on various aspects of the research that takes place within the group. While we will receive fewer guests in the current semester given that many of the group's researchers are conducting, or are about to conduct field research, we are excited to have a range of guests already confirmed for the 2019 summer semester and thereafter.

The present newsletter primarily reports on the many scholarly activities of the group's researchers in terms of presenting and publishing their work.
