

Dear friends and colleagues,


with an end of most of the pandemic restrictions (although not the pandemic itself) in sight, our lives have now been overshadowed by the Ukraine war, both by its tragedy and by the atrocities committed by the Russian armed forces, as well as the fearful prospects of what it might yet bring.

It is little comfort in this situation that this war reminds us of the core research programme of our group: namely, that in world politics there usually are no simple answers, and that analysing complex social settings requires taking into account various simultaneous, and oftentimes overlapping and conflicting, modes of observation, historical trajectories and ordering principles. Reminding ourselves of this seems particularly important when many simplifying analytical accounts compete for interpretative dominance.

It is in this spirit that we will continue our work.
