Note: Structured doctoral programmes are understood to be programs for promoting doctoral students that offer a structured program of events for all participants and meet two of the following three conditions: (1) joint responsibility for the supervision of the doctoral students by the university teachers involved, (2) open, competitive admission procedure with advertisement, (3) Grants or positions for at least some of the participating doctoral students

Type of doctorate

- Doctorate at universities with the right to award doctorates (including cooperation with another university in Germany)
- Doctorate at universities with the right to award doctorates in **institutional** cooperation with:
 - a university abroad
 - a university of applied sciences
 - a research institution
 - institutions in industry and private sectors

Note: A cooperation should only be entered if it is an institutional cooperation, i.e. the cooperation is based on a contract or an agreement at the level of the institution. In the case of several cooperations, only the first applicable variant is to be reported.

Registration as a doctoral candidate

- First registration** as a doctoral candidate at a German university
- Re-registration** as a doctoral candidate after a successfully completed or aborted doctorate. Re-registration also applies if the doctoral candidate has changed the university of the doctorate.

Desired type of dissertation

- Monograph
- Publication-based/cumulative dissertation (creation of several scientific articles, which are then assessed together)

Note: Always register the current status of the desired type of dissertation. Changes in the type of desired dissertation may occur in the course of time.

If any changes to the information above occur over time, these must be communicated to the student registry immediately and unprompted using this form.

Language requirements

- German language proficiency is not required for this doctoral project (only check for doctoral candidates without sufficient proof of German language proficiency and for doctoral projects not done in German).
